THE PROGRAM PROVIDES DEDICATED, RECURRING OPPORTUNITIES FOR COMMUNITY LEADERS AND RESIDENTS TO DEEPEN CONNECTIONS AND COLLABORATE ON SOLUTIONS. ALL COMMUNITY COUNCIL MEETINGS ARE OPEN TO THE PUBLIC. IN ADDITION TO IN-PERSON CONVENINGS, UNITED WAY OF ALAMANCE COUNTY DISTRIBUTES REGULAR COMMUNITY COUNCIL EMAIL ANNOUNCEMENTS TO KEEP COMMUNITY MEMBERS INFORMED ABOUT LOCAL INITIATIVES, EVENTS, AND ENGAGEMENT OPPORTUNITIES ACROSS THE COUNTY.

THE EXECUTIVE COMMITTEE IS THE PRESIDENT, BOARD CHAIR, AND TREASURER. THEY MEET WEEKLY TO CHECK IN WITH THE ORGANIZATION AND CONFIRM CURRENT ACTIVITIES. THE BOARD MEETS MONTHLY, AND ANY ISSUES THAT ARISE DURING THE EXECUTIVE MEETING CAN BE PRESENTED TO THE FULL BOARD. THIS EXECUTIVE COMMITTEE IS TO PROVIDE SUPPORT TO THE PRESIDENT AND ASSIST IN ANY DAY-TO-DAY DECISION-MAKING THAT MAY BE NEEDED.

BOARD MEMBERS AND OFFICERS ARE ASKED TO COMPLETE A CONFLICT OF INTEREST POLICY AND LIST AFFILIATIONS AND ASSOCIATIONS ANNUALLY. BOARD CHAIR AND PRESIDENT MONITOR COMPLIANCE WITH THIS POLICY. IF A CONFLICT OF INTEREST WERE TO OCCUR A NOTIFICATION TO THOSE WHO OVERSEE THE POLICY WOULD HAPPEN.

THE BOARD CHAIR AND EXECUTIVE COMMITTEE REVIEW AND APPROVE THE COMPENSATION OF THE PRESIDENT AND THIS PROCESS IS DOCUMENTED. THE BUDGET CREATION IS USED TO ESTABLISH RAISES AND SALARY ADJUSTMENTS. THIS TAKES PLACE DURING MAY AND JUNE OF THE PRIOR YEAR.
