

2019 ALAMANCE COUNTY AWARD FOR OUTSTANDING VOLUNTEER SERVICE

NOMINATION ELIGIBILITY AND SUBMISSION GUIDELINES

ELIGIBILITY

- **Nominees must have been engaged in volunteer activities for a minimum of one year in Alamance County and benefited a community or communities in the county in a substantial, important or unique way.** Volunteer service performed outside the county will not be considered.
- Students receiving course credits for their volunteer activities are ineligible unless the nomination is based upon volunteer service that extends **beyond** the course requirements, in which case it must be clearly indicated in the nomination statement.
- National Service volunteers must be nominated for service **above and beyond** that which is required of them in their national service program. Volunteer time recorded in a national service program will not be eligible.
- Previous award recipients from within the past 10 years are ineligible (see page 2).
- Nominees are ineligible if they receive compensation for their service, with the exception of paid Directors of Volunteers.
- Nomination cannot be based upon court-mandated community service.
- Nomination cannot be based upon serving as a "loaned executive."
- Self-nominations are **not** permissible.
- Family members may **not** nominate another family member for an award.
- Group/team and corporate volunteerism nominations must be made by those **external** to the group/team or corporation/business.
- **All nomination submission requirements** must be met.
- Director of Volunteers who are paid for their service must be nominated in the non-volunteer service category.

IMPORTANT SUBMISSION REQUIREMENTS

- All nominations must be submitted through the official 2018 Alamance County's Award for Volunteer Service portal on the following website: <https://uwalamance.org/get-involved/volunteer/>.
- Only fully completed nomination forms will be accepted. **All sections must be completed.** Incomplete nominations will not be considered for the award.
- While we regret any inconvenience it may cause, all nominations must be typed. **Handwritten forms will not be accepted.**
- One additional reference is **required** for each nomination.
- The nominator may **not** serve as the only reference.
- Nomination attachments/supporting documentation (photographs, letters, etc.) will **NOT** be accepted.
- ***The deadline to submit all nomination forms to Community Council is Friday, November 8, 2018.***

AWARD SELECTION

- Award selections are based on the nominee's volunteer efforts and commitment of time, accomplishments, community impact and enhancement of the lives of others, as described on the nomination form.
- The Community Council Executive Committee will select award recipients based on merit and eligibility. Recipients are selected without regard to race, religion, gender, national origin, or physical/mental disability.
- In the past, many of the nominated individuals were featured in a Times-News article as part of their series called, *Celebrate Community*.
